How do you remove a unused SSD cable from a power supply?

If the cable can be removed from the power supply without removing any other cables, then the power supply is modular and the unused SSD cable can be safely removed. If the power supply is not modular, tuck the unused SSD cable into space next to the power supply. Use a zip tie to secure it out of the way, if needed.

How do you remove a solid-state drive from a PC?

If the power supply is not modular, tuck the unused SSD cable into space next to the power supply. Use a zip tie to secure it out of the way, if needed. Slide the side panels of the case back into place, and secure with the appropriate screws as necessary. The solid-state drive has been successfully removed from the PC.

How do you remove an SSD from a motherboard?

Locate the SSD. In most cases, it will be mounted in a bay next to the motherboard. Remove the screws holding the SSD in the bay. Gently slide the SSD out of its bay slot. Unplug the two cables which are connected to the back of the SSD. The SSD is now removed, but there are two cables left in its place.

How do I remove the SSD shield from my Motherboard?

Lift the center chassis off of the motherboard and heatsink assembly. Route the interconnect cable through the cutout on the center chassis as you remove it. The SSD shield has thermal pads on either side, so ensure these are kept as intact as possible during this procedure. Use the flat end of a spudger to pry up the edges of the metal SSD shield.

How do I remove a vibration isolator from an optical drive?

Use a T8 Torx driver to remove the two 8.8 mm screws securing the optical drive's vibration isolator to the shell: one on the base and one on the top of the isolator. Lift up the optical drive's vibration isolator to remove it.

The failure mode you mention, involving unexpected power loss, is not simply because power is removed, but is due to the way SSDs manage data on their NAND. Some relevant background follows:
