Will European Commission impose anti-dumping duties on Chinese solar panels?

The European Commission today decided to impose provisional anti-dumping duties on imports of solar panels and key components (i.e. cells and wafers) from China. An investigation found that a Chinese solar panel is sold to Europe far below its normal market value.

#### Does the EU impose a dumping duty on solar panels?

the imposition of measures is not against the Union interest. On the basis of these findings, it has been decided to impose an anti-dumping dutyin a two-staged process: for two months, a duty of 11.8% will have to be paid, whereas from 6 August, duties ranging from 37.3% to 67.9% (averaging 47.6%) will be levied on solar panels from China.

#### How did China respond to EU dumping and anti-subsidy investigations?

China responded with anti-dumping and anti-subsidy investigations into EU wine imports but the EU measures were nevertheless renewed in 2015 and 2017, with the duties reduced to 30 percent and the minimum import price adjusted to align with global market rates.

#### Why did the EU impose anti-dumping duties?

The Commission imposed definitive anti-dumping duties in three different cases this week, covering EUR912 million in unfairly priced imports and helping to protect 19,000 European jobs. The anti-dumping measures concern:

It has reportedly said that European manufacturers would be incensed if the measures ended. The EU first imposed anti-dumping and anti-subsidy measures in December 2013 for a period of two years. These were then renewed in March 2017 for a period of 18 months only, as opposed to the usual five years.

Due to the EU"s reliance on imported solar panels to accelerate the growth of its renewables and reach the 2030 targets, the commissioner ruled out the implementation of anti-dumping measures to ...

1. An anti-dumping duty may be imposed on any dumped product whose release for free circulation in the Union causes injury. 2. A product is to be considered as being dumped if its export price to the Union is less than a comparable price for a like product, in the ordinary course of trade, as established for the exporting country. 3.

The US Department of Commerce (DOC) has released a final regulation aimed at enhancing the anti-dumping and countervailing duty (AD/CVD) regulations. This ultimate decision closely follows the DOC"s proposed rules from May 2023, with slight adjustments intended to bolster the enforcement and management of the AD/CVD laws.
