

Is energy storage a profitable business model?

Although academic analysis finds that business models for energy storage are largely unprofitable, annual deployment of storage capacity is globally on the rise (IEA, 2020). One reason may be generous subsidy support and non-financial drivers like a first-mover advantage (Wood Mackenzie, 2019).

What are business models for energy storage?

Business Models for Energy Storage Rows display market roles, columns reflect types of revenue streams, and boxes specify the business model around an application. Each of the three parameters is useful to systematically differentiate investment opportunities for energy storage in terms of applicable business models.

Are energy storage products more profitable?

The model found that one company's products were more economic than the other's in 86 percent of the sites because of the product's ability to charge and discharge more quickly, with an average increased profitability of almost \$25 per kilowatt-hour of energy storage installed per year.

Is it profitable to provide energy-storage solutions to commercial customers?

The model shows that it is already profitable to provide energy-storage solutions to a subset of commercial customers in each of the four most important applications--demand-charge management, grid-scale renewable power, small-scale solar-plus storage, and frequency regulation.

Why should you invest in energy storage?
