Does Italy need an efficient energy storage system?

Does Italy need a small storage system?

"Storage needs to be considered, also in line with the European approach, as a market player, similar to a generating asset," said Canazza.

Are energy storage facilities regulated in Italy?

The Italian regulatory framework concerning energy storage facilities has been evolving rapidly in recent years. However, the legislation is relatively fragmented, given the high number of laws governing different aspects of energy storage facilities.

Why are battery energy storage systems not being developed in Italy?

The development of Battery Energy Storage Systems (hereinafter "BESS") in Italy has been limited by the fact that the spread of renewable sources is not such as to produce significant price differences during the hours of the day yet. An unfavourable legal and regulatory framework has also contributed to the low diffusion of BESS.

Can batteries be used for energy storage in Italy?

In Italy,batterieshave become an attractive technology for electricity storage projects although they are not traditionally used.

Energy Storage. Local industry contacts and U.S. companies in the sector have indicated to CS Italy a need for long-duration energy-storage solutions. As of April 2023, Italy had more than 300,000 storage systems, with a total power of about 2,350 MW and a maximum capacity of about 4,000 MWh.
