The recalled battery allows owners to capture and store energy from the solar panels. The batteries are wall mounted and measure 29.30 x 35.70 x 8.10 inches. They weigh roughly 220 pounds.

What if my LG battery is recalled?

Consumers with recalled batteries should immediately contact LG Energy Solution Michigan to schedule a free replacement. LG Energy Solution Michigan will arrange for modifications to recalled batteries that are connected online to reduce the risk of overheating until they can be replaced with new batteries.

What is LG Energy Solution Michigan doing about the recalled batteries?

LG Energy Solution Michigan, its distributors and its installers also are attempting to contact all owners directly to arrange for modifications to the recalled batteries to reduce the risk of overheating until they can be replaced with new batteries.

Are recalled LG batteries enforceable?

Additional advice from the ACCC dated 27 May 2024: On 17 May 2024, the ACCC accepted an enforceable undertaking from LG Energy Solution to take actions to protect consumers from risks posed by these recalled LG batteries.

What happens if a LG ESS battery overheats?

The Australian Competition and Consumer Commission is calling on consumers to take "urgent action" and visit the LG ESS website to check if their batteries are affected. "If a battery overheats, it may catch on fire and cause injury or death or damage to property. Incidents have occurred and caused damage to property," the ACCC stated on Friday.

Are Resu 10h batteries a fire hazard?

The home batteries can overheat, posing a risk of fire and emission of harmful smoke. About 10,000 (In addition, 2017-2019 RESU 10H were previously recalled for a fire hazardon December 16,2020.)
