## Midstream energy storage investment

What does a midstream energy company do?

Midstream energy companies build and operate pipelines and storage facilities for the transportation of domestic energy supplies critical to the nation's economy. These companies own the infrastructure that connects the energy raw commodity to the end user.

Are Exploration & Production companies better than midstream companies?

Compared to exploration and production companies, midstream companies pay more attractive yields, and they have a lower correlation with oil prices, she says. Exploration and production companies, known as E&Ps, have more direct exposure to commodity prices than midstream companies, she adds.

Should you invest in the midstream business?

"Some have a national focus on huge pipeline assets. Others are more local and focused on gathering and storage. "There is no best way to invest in the midstream business since there are pros and cons to each strategy, Bright says.
