The determination and willingness of the Mozambican government to establish Mozambique as a regional energy hub due to its abundant resources and substantial gas discoveries make the country very attractive for investment.

The energy storage system was provided by E22, part of the Spanish group Gransolar, while another Spanish company TSK provided engineering, procurement and construction (EPC) services. The project is part of Mozambique's plan to deploy 200MW of renewable energy over a five-year period, and is the third large-scale solar plant in Mozambique.

What does the EPC market need in Mozambique? Multinational corporations must prioritise collaborating with established Mozambican companies by granting them direct contracts and not via their designated EPC contractors. Instead of solely relying on their international teams, EPC companies should actively seek partnerships with local businesses.
