

What is the energy consumption in oilfields?

The energy consumption in oilfields is relatively high, except for the drilling, energy is required for crude oil transport, acid gas treatment, and gas dehydration. However, with the low level of energy management strategy in some of the oilfields, the energy utilisation efficiency has great potential to be improved.

Are oil and gas fields a geothermal resource?

One study in Italy showed that the geothermal potential of selected oil and gas fields is encouraging [66]. Some cases convert oil extraction sites to geothermal plants; one example is Soultz-sous-Forêts [67]. Singh et al. [68] developed a field-scale hydro-thermal model to study the heat extraction potential of Soultz-sous-Forêts.

Which rigs have energy storage systems for onshore drilling?

The energy storage system developed for onshore drilling is among the world's first ones. As a foreign analog, only the project of the German rig manufacturer Bentec implemented in Oman can be highlighted. In 2017, the container-type 0.9 MW Bentec ESS with a storage capacity of 0.3 MW was put into trial operation on the KCA Deuteg T-94 rig.
