As electricity storage is a relatively undeveloped field in Poland, there are still no detailed acts in Polish law which refer to it. Following the December 2023 Capacity Market Auctions in Poland, 1.7GW of BESS were awarded contracts. Prices, however, were significantly lower than expected, at around £19000 per MW - approximately 40% lower than the previous year.

PGE is also developing a battery energy storage facility at the ?arnowiec pumped storage power plant (southern Poland) with a capacity of at least 200 MW and a storage capacity of over 820 MWh, planned for commissioning in 2027. By 2030, the company aims to have at least 0.8 GW of new energy storage capacity.

Pumped hydro energy storage (PHES), meanwhile, has a de-rating factor of 96% while power plants including gas and nuclear have around 93-95%. A "dangerous" move for Poland. Micha? Ma?kowiak, managing director of the Poland arm of BESS developer Harmony Energy, was unequivocal in his comments about the proposal to Energy-Storage.news.

The draft parameters for this year's capacity market auction in Poland could make the rollout of battery energy storage systems (BESS) much more difficult. Poland is one of the emerging energy storage markets in Europe, with an installed capacity of 44 MW in 2023 and expected to reach 4.6 GW in 2030, and pre-table energy storage is its main development direction. The global energy storage market is experiencing rapid growth, driven by the increased demand for renewable energy integration and grid stabilisation. According to data from the Polish Chamber of Energy Storage, by the end of 2022 there were about 7,000 backyard energy storage facilities in Poland with a total capacity of 27.5 MW and a capacity of 55 MWh. About 2,000 such devices have been installed since 2021, when government subsidies for their purchase were introduced. ...
