

How many projects in Poland have received a grid connection offer?

As of October 2023, around 9 GW of projects have received grid connection offers from Poland's Transmission System Operator PSE. Only 6 projects with a total capacity of around 1.5 GW, have agreed on the proposed terms with the TSO, with an expected connection date post-2027.

When will battery energy storage be available in Poland?

In September 2022, Romania announced a goal to deploy 480 MWh of battery energy storage by 2025. In Poland, the proposal for power market reform was released in March 2023, which encouraged battery energy storage to enter the market and promote investment for the technology.

What happened at Poland's capacity market auction?

The results of Poland's recent capacity market auction have been revealed, with a clearing price significantly lower than the previous years and IPP Greenvolt saying it won the lion's share of around 1.7 GW of BESS awarded contracts.

What is the biggest energy storage project in Sweden?

Neoen and Nidec announced construction of a 9 MW/93.9 MWh BESS- the largest BESS project in both Sweden and all of Northern Europe. It is expected to enter operation in the first half of 2025. BESS remained the mainstay of energy storage projects over the quarter, with a small number of PHS projects promoted.

How much solar power will Poland have in 2022?

Poland recorded 12.4 GW of installed PV capacity at the end of 2022, according to data from the Polish research institute Instytut Energetyki Odnawialnej (IEO). The institute estimates the country's installed solar capacity could more than double to 26 GW by the end of 2025, with 5 GW of solar projects added to the grid last year.

Will the capacity market kickstart the large-scale Bess market in Poland?

The capacity market is set to kickstart the large-scale BESS market in Poland by providing the basic building blocks of the business case, according to numerous delegates interviewed by Energy-Storage.news at Energy Storage Summit Central Eastern Europe (CEE) 2023 in Warsaw in September.

On October 30, State Grid Hunan Comprehensive Energy Service Co., Ltd. issued a bidding announcement for four renewable energy bundled energy storage projects in the cities of Chenzhou, Yongzhou, Loudi, and Shaoyang. Bidding has been divided into four contracts, which include 22.5 MW/45 MWh of capacity.

The draft parameters for this year's capacity market auction in Poland could make the rollout of battery energy storage systems (BESS) much more difficult. The document proposes a significant reduction to the BESS derating factor that could be particularly harmful for longer duration storage systems.

Jan Kloczko, the firm's deputy commercial director for Europe, discussed the wins, the status of the projects, its activity in Hungary and more in this Q& A interview whilst at Solar Media's Energy Storage Summit Central and Eastern Europe (CEE) 2024 in Warsaw, Poland last week.. OX2 only bid around 20MW of the Poland project's power capacity to the auction as it required a four-hour duration. The contract obligation starts in 2027 so the project will need to be online by then but the company is "looking at all options" for bringing it online earlier than that, van Asseldonk added, as it depends on what happens ...

A total of 165MW of BESS projects won awards in the auction, Hynfra founder and CEO Tomoho Umeda said. The largest winning projects were 21MW of capacity from a 50MW/100MWh project by Sweden-based developer OX2 and a 120MW/500MWh project from Columbus Energy. For the upcoming one in December, 16GW of BESS got preliminary ...

It awarded contracts to 159 projects totalling over 7GW of power, of which 111 are in Poland and 48 are abroad in Czech Republic, Slovakia and Sweden. The clearing price is significantly lower than the PLN 406.35/kW at which the previous auction cleared, for deliverability in 2027. Battery storage projects from Hynfra Energy Storage and OX2 totalling 130MWh have won contracts in energy auctions in Poland this week. A capacity market auction for 2027 from transmission system operator Polskie ...

A total of 93 projects were submitted into the auction, with 12 winners, 3 runner-ups and 78 projects which were excluded from the final list. Projects bid in with a desired annual aid amount, with a weighted average of the winning projects of EUR49,748 per MW per year. This is less than half of the upper limit that projects could bid in at, of EUR115,000.

At the end of 2022, BESS projects were included in the bidding for energy projects in Poland for the first time. In January 2024, the Polish Energy Regulatory Office announced the results of the energy storage tender, and Greenvolt became the biggest winner of the bidding, winning 6 projects with a total of 1.2 GW.

Poland, Europe's tenth-largest economy, is set to become a hotbed of energy storage project development as the share of renewable energy on its grid soars. The country built out a record 1.2 GW of onshore wind power in 2023, according to ...

Based on partial statistics, there were 26 new energy storage bidding projects in June, with a combined capacity of 7.98GWh. Among them, framework procurement projects accounted for 4.4GWh, household energy storage projects accounted for 2.6GWh, and new energy distribution storage projects accounted for 0.9GWh.

Over a gigawatt of bids from battery storage project developers have been successful in the first-ever competitive auctions for low-carbon energy capacity held in Japan. A total 1.67GW of projects won contracts, including 32 battery energy storage system (BESS) totalling 1.1GW and three pumped hydro energy storage (PHES) projects totalling 577MW.

Harmony Energy Poland bid in around 500MW to last year's auction, unsuccessfully, while this year it will bid in 400MW split across two BESS projects. "At first glance, it did look like the de-rating factor cut killed the business case for BESS but it's not quite the case," Małkowiak said, commenting on the de-rating cut from 95% to 61 ...

It said that construction had begun on the Oasis de Atacama battery storage project, which will be the "largest in the world" with 4.1GWh capacity and a further 1GW of solar PV generation. The project will represent a

total US\$1.4 billion. It will be built in five phases and will "come on stream" over the next 36 months.

Image: Atlas Renewable Energy. The Chilean Ministry of Energy has opened a public land bidding auction seeking 13GWh of standalone energy storage projects. In coordination with the Ministry of National Assets, the programme aims to allocate energy storage capacity across four regions - Arica and Parinacota, Tarapaca, Antofagasta and Atacama.

PGE is also developing a battery energy storage facility at the Żarnowiec pumped storage power plant (southern Poland) with a capacity of at least 200 MW and a storage capacity of over 820 MWh, planned for commissioning in 2027. By 2030, the company aims to have at least 0.8 GW of new energy storage capacity.

Pumped hydro energy storage (PHES), meanwhile, has a de-rating factor of 96% while power plants including gas and nuclear have around 93-95%. A "dangerous" move for Poland. Energy storage developer Pacific Green has agreed to acquire two large-scale in-development battery energy storage system (BESS) projects in Poland, Europe. The acquisition of two 50MW projects totalling 400MWh of capacity marks the developer's first entry into Poland, which is fast becoming a key market for energy
