

How many battery energy storage projects have won a bid?

Over a gigawatt of bids from battery storage project developers have been successful in the first-ever competitive auctions for low-carbon energy capacity held in Japan. A total 1.67GW of projects won contracts, including 32 battery energy storage system (BESS) totalling 1.1GW and three pumped hydro energy storage (PHES) projects totalling 577MW.

Does Pyongyang use natural resources?

How many GW of energy projects won a contract?

A total 1.67GW of projects won contracts, including 32 battery energy storage system (BESS) totalling 1.1GW and three pumped hydro energy storage (PHES) projects totalling 577MW. The winning projects came from a pool of nearly 4.6GW of qualifying bids.

Battery storage projects from Hynfra Energy Storage and OX2 totalling 130MWh have won contracts in energy auctions in Poland this week. A capacity market auction for 2027 from transmission system operator Polskie Sieci Elektroenergetyczne (PSE) closed at PLN 406.35/kW/year (US\$93) and handed out long-term contracts to energy resources.

Projects bid in with a desired annual aid amount, with a weighted average of the winning projects of EUR49,748 per MW per year. This is less than half of the upper limit that projects could bid in at, of EUR115,000.

Contexts: Ministry of Power has released draft guidelines for Tariff based competitive bidding for procurement of storage capacity/stored energy from pumped storage plants. The draft proposes a single stage two-part bidding process, consisting of technical and financial bidding stages for procuring storage capacity from pumped storage projects.

The proposed process includes both technical and financial bidding stages, aiming to streamline the procurement of energy storage from these projects. Earlier this week, the Ministry released draft tariff-based competitive bidding (TBCB) guidelines for PSPs, inviting feedback from stakeholders by the first week of September 2024.
