

Soliciting opinions on power storage standards

What is the 'guidance' for the energy storage industry?

Based on the above analysis, as the first comprehensive policy document for the energy storage industry during the '14th Five-Year Plan' period, the 'Guidance' provided reassurance for the development of the industry.

Will energy storage eliminate industrial development?

In the context of the 'dual-carbon' goal and energy transition, the energy storage industry's leapfrog development is the general trend and demand. The follow-up actions will inevitably introduce a series of policies for the development of energy storage to eliminate industrial development. Faced with 'obstacles' one by one.

How many provinces and cities in China are implementing energy storage policies?

At present, more than 20 provinces and cities in China have issued policies for the deployment of new energy storage. After energy storage is configured, how to dispatch and operate energy storage, how to participate in the market, and how to channel costs have become the primary issues which plague new energy companies and investors.

Can independent energy storage providers apply for a business license?

Independent energy storage providers in Fujian, Jiangsu, Shanxi and other regions are permitted to apply for power generation business licenses, and are permitted to participate in ancillary services provision. Renewable energy + energy storage becomes a leading trend, but commercial development still faces difficulties.

How to improve energy storage industry?

1) Strengthening planning guidance to encourage the diversification of energy storage; 2) Promoting technological progress to expand the energy storage industry system; 3) Improving the policy mechanism to create a healthy market environment; 4) Standardisation of industry management to improve the construction and operation.

Will energy storage industrialization be a part of the 14th five-year plan?

While looking back on 2020, we also looking forward to the development of energy storage industrialization during the 14th Five-year Plan, as policy and market mechanisms become the key to promote the full commercialization and large-scale application of energy storage.
