Financial close has been reached for a 25MW / 100MWh battery energy storage system (BESS) project in Belgium which has also been successful in a grid capacity auction alongside gas-fired power plants.

The Ministry of Energy announced that by September 2025, GEI Power, a Zambian developer, and YEO, a Turkish energy technology firm, aim to have a 60MWp solar PV and 20MWh BESS project operational in Zambia. This endeavour, requiring an investment of \$65 million, is anticipated to alleviate power shortages in the country.

Renewable energy developer and independent power producer (IPP) Greenvolt won 1.2GW of 17-year contracts for six battery energy storage system (BESS) projects it bid in, the company revealed on the same day. It claimed this equated to over 70% of total capacity awarded to BESS technology, implying the total awarded to BESS was around 1.7GW.

The project would also "place Zambia at the centre of renewable energy trading across southern Africa" through the Southern Africa Power Pool (SAAP), the international power grid between a dozen countries in southern Africa. That pilot project will then inform an expanded 400MWh battery energy storage system (BESS) rollout across the country.
